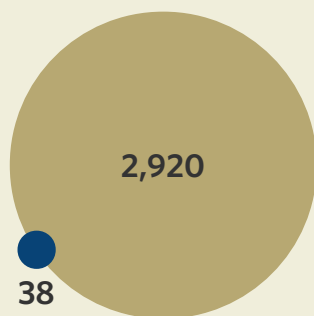

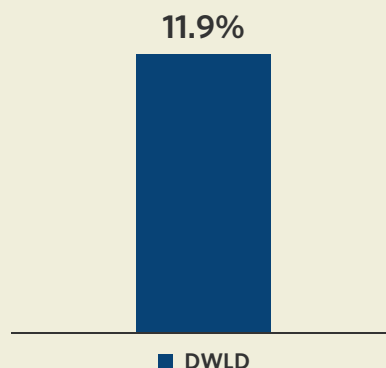

EPS Growth (5 Year)¹

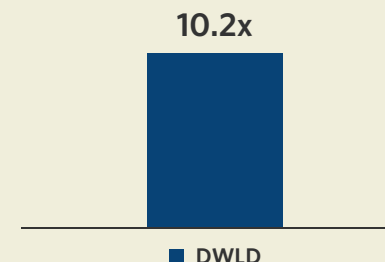
